  - Saturday, September 17th, from 1:00pm-6:00pm
  - Saturday, December 17th, from 1:00pm-6:00pm
- If Venue is properly licensed to do so, then wine and / or beer may be served during Art Walk Reception (*if licensing information needed, contact Victoria Main Street Staff*).
- Inquiries about the sale of work(s) will be referred to the Artist(s).
- No commission will be paid on sales of exhibited works. Sales are to be made directly with the Artist.
- Reasonable security will be provided during the entire time the works are displayed.
- No changes will be made to the map and marketing information within seven days of the selected art walk date.
- Hold harmless and indemnify City of Victoria, Crossroads Art House, Victoria Art League, Inc., the Artist, including its officers, agents, and employees from and against all claims, demands, damages, or costs arising from property damage to the artwork and from any bodily injury connected with or arising from the display of such artwork.
